

RATES

Prices listed must be increased by the current VAT, except for amounts defined as "penalties." They may undergo changes related to specific promotional offers and are subject to change without notice.

1) DEBIT AMOUNTS

RCA (Civil Liability Insurance) ensures coverage for third-party liability concerning individuals, property (excluding transported items), and animals. The transported person in the Edilfar Rent vehicle is considered a third party. The RCA insurance coverage is included in the tariff and has a unique and overall limit of 25 million euros.

a) Theft Debit Amounts (TP) and Supplementary Elimination/Reduction of Debit Amount (STP)

All Edilfar Rent rates include the TP service. The TP service is not insurance coverage but a conventional reduction of the Customer's liability in case of total and/or partial theft or fire within the limits of a maximum amount due by the Customer to Edilfar Rent at the event occurrence. This maximum amount chargeable per event varies based on the rented vehicle group and is shown in the table below:

b) Damage Debit Amounts (CDW) and Supplementary Elimination/Reduction of Debit Amount (SCDW)

All Edilfar Rent rates include the CDW service. The CDW service is not insurance coverage but a conventional reduction of the Customer's liability for damages found on the vehicle during the rental, including those resulting from accidents. The conventional reduction of liability occurs within the limits of a maximum amount chargeable per event, which varies based on the rented vehicle group and is shown in the table below:

c) Supplementary Elimination/Reduction of Theft and Damage Debit Amounts (SCP) The Super Cover Protection (SCP) supplement includes SCDW and STP. This supplement is not insurance coverage and, if subscribed at the time of rental, eliminates the amount due by the

customer in case of damage, total theft, partial theft, or fire. This liability exclusion is not effective or lapses for damages or theft of glass, tires, and/or rims. The SCP supplement cost per day is ϵ 20.00.

d) Supplementary Elimination/Reduction of Theft and Damage "Full Coverage" Debit Amounts (SCP Full Coverage)

The Super Cover Protection Full Coverage (SCP Full Coverage) supplement includes SCDW, STP, and SCP. This supplement is not insurance coverage and, if subscribed at the time of rental, eliminates the amount due by the customer in case of damage, total theft, partial theft, or fire, including damage or theft of glass, tires, and/or rims.

The SCP Full Coverage supplement cost per day is €25.00.

2) SERVICES, ACCESSORIES, AND SUPPLEMENTS

Below are the economic conditions of the services, accessories, and supplements that can be purchased by the Customer.

Optional Services

- Second Driver: €7.00 per day.
- Urban delivery and/or pickup at home: €24.59 per trip.
- Out-of-office hours delivery and/or pickup (upon specific request): €50.00.
- Holiday delivery and/or pickup (upon specific request): €50.00.
- FCO APT/LIN delivery/pickup: €65.00 per trip.
- MPX APT delivery/pickup: €100.00 per trip.
- Unlimited kilometers: €10.00 per day for Economy cars; €15.00 per day for other cars and commercial vehicles.
- Early Fueling: The customer will pay for a full tank of fuel based on the capacity of the rented vehicle's tank (€60 to €100), and must simply return the vehicle with the remaining fuel in the tank (no refunds for unused fuel).

- Refueling Service: €20.00
- Administrative Fees/Invoice Issuance Administrative Cost: €5.00 per invoice.
- Key loss: Specific tariff will be applied depending on the rented vehicle model, ranging from €300.00 to €700.00.
- Plate loss/damage: €300.00.
- Registration card loss/damage: €100.00.
- Loss/damage of inspection/certificate of insurance: €30.00.
- One way (authorized solo trip): €74.00.
- Cross Border: (with prior authorization) €50 per rental.

Accessories

Upon request and subject to availability:

- Child seats (booster/baby/child seat): €40.00 per rental.
- Winter tires: €15.00 per day (maximum charge €105.00).
- Snow chains: €7.00 per day (maximum charge €49.00).
- GPS Navigation: €12.00 per day (maximum charge €84.00).

• Electric Vehicle Charging Card: €15 per rental. Charging expenses incurred with the charging card will be charged based on current market rates.

3) PENALTIES

Customer costs will be charged in the following cases:

- Penalty for damage/non-return of chains: €100.00.
- Penalty for damage/non-return of baby seat: €100.00.
- Penalty for damage/non-return of GPS navigation: €150.00 for smart cars; €700.00 for Mercedes cars.
- Penalty for damage/non-return of electric vehicle charging cards (only for electric vehicles): €100.00.
- Penalty for damage/non-return of charging cables (only for electric vehicles): €800.00 per cable.
- Unauthorized additional driver penalty: €61.00.
- Compensation penalty resulting from a passive accident: €300.00.
- Penalty for delayed and/or omitted report of accident communication: €500.00.
- Penalty for unauthorized Border Crossing: €150.00.
- Smoking Penalty: €50.00.
- Penalty for Occupying a Charging Station without Charging: In case, after charging using a card provided by Edilfar Rent, the Customer does not move the vehicle within 1 hour of the end of the charge, a specific tariff of €0.20 per minute of delay will be applied.

4) MISCELLANEOUS

- Claim Processing Fee: €50.00.
- Mileage Excess: In case of mileage exceeding what is provided by the purchased rate, a specific tariff will be applied to the customer, ranging from €0.30 to €0.50 + VAT per additional kilometer, depending on the rented vehicle group. In any case, Edilfar Rent reserves the right to act for greater damages.
- Fines/Notices Re-notification: €40.00 per fine/communication.
- Non-payment toll re-notification: €15.00 per fine/communication.
- Management of fines/notices in case re-notification is not possible: €20.00 per fine/communication (in addition to the fine cost).
- Extraordinary vehicle cleaning: €50.00.
- Vehicle sanitization: €100.00.
